Minutes from March 26th -

PBAC was given a month to review the budget allocation requests, supporting material and recommendation brought forward from BASC. The committee was encouraged to review the supporting material, audio recordings and questions that are posted on the BASC website. BASC is recommending to PBAC that the top seven requests listed have merit. Patrick Stanton made the motion to recommend funding the first three items (in blue), and for the next four items (in golden rod) to be recommended for consideration of funding. Gregory Heinselman seconded. Tim Englund made the motion to amend the recommendation by Patrick to vote on the top three items (in blue) individually. David Pena-Alfaro seconded, 1 abstention. Motion carried.

Much discussion was had regarding the funding request to add three FTE Financial Aid Counselors. Gregory Heinselman made the motion to recommend approval to fund two positions from 149 funds, contingent on filling the positions. The third position will need to be brought back as a request next year. Patrick Stanton seconded. 10 yeah. Motion carried.

Paul Ballard made the motion to recommend funding the Library request at the discretion of the Provost/ASL, Gregory Heinselman seconded. 7 yeah – 3 abstentions. Motion carried.

Cody Stoddard made the motion to recommend funding the Admissions request, David Pena-Alfaro seconded. No action taken. 1 yeah – 7 nay. Motion failed.

Cody Stoddard motioned to recommend consideration of 8-16 (Golden Rod section) as a whole, Tim Englund seconded. Motion carried.

Patrick Stanton made the motion to move 8-16 forward for consideration for funding, Cody Stoddard seconded. 4 yeah – 6 nay. Motion failed.

Cody Stoddard made the motion to not recommend funding 8-16, Paul Ballard seconded. 9 yeah -1 nay. Motion carried.
