# Presentation from Wildcat Pantry

- How \$6 gets you over \$200 worth of groceries:
- The Wildcat Pantry fee referendum is a new proposed mandatory fee for CWU Ellensburg undergraduate and graduate students.
- Students will vote to add a quarterly charge of
  - \$6= minimal operational costs
  - \$10= further food assistance and essential services
  - o Ex: eligible student receive \$/month
  - No Wildcat Pantry fee
- Why mandatory?
  - Financial aid and loans cover mandatory fees. Ensures pantry service remains available to any student.
- Why the fee?
  - The pantry can focus their time on building new services and directly supporting the student body.
  - Grants, scholarships, and Federal/State funding are precarious and very time consuming.
  - Guaranteed funding every year.
  - Can start next fall rather than waiting 2-3+ years on campus/state funding.
  - Campus funding is impacted by enrollment and administrative priorities.
  - Putting the pantry at risk to potential budget cuts.

- The pantry can focus their time on building new services and directly supporting the student body.
- Student voice & agency.
- It is not permanent. Students can decide to reduce, increase, or remove the fee if other funding sources become annual and reliable.

- Serves all students.
- o Students will always have the safety net to use the pantry if something arises.
- What will the fee pay for?
  - Paid student positions
  - (Restock and maintenance of the Wildcat Pantry)
  - Creation and expansion of basic need programs
- How \$6 serves every student.
  - Available to any CWU student!
  - No qualification besides your connection card.
  - By visiting the pantry (minimum) once a quarter, you have already made your money back with a return on investment!
  - AVG shopper takes 8 items
  - Cost per unit is \$1.5
  - One trip is valued at \$12
  - We expect ROI to increase as we receive more produce, dairy, and meat options in the next year.
- Numbers: Since reopening the Wildcat Pantry this academic year (~100 days)...
  - o 66% increase in number of visits (1200)
  - 71% increase in items distributed (9300)
- Public Health Concern
  - Public Health Concern
  - 47% of CWU students experience food insecurity (WSAC, 2023).
  - 34% is the state average.
  - If left unaddressed, these challenges may have lasting implications on college students' health and degree completion (Stebleton, 2020).
- How is the pantry currently funded?
  - Donations to the PUSH foundation account, Amazon Wishlist, or physical items (covers restock & program costs)
  - Campus pays for staff positions.
  - o Most established pantries receive their funding from a student fee:
    - Portland Community College: All recognized PCC students pay the fee of \$3.40 per credit. Student Activity Fee supports their food pantries, emergency resources, event/activities, and more.
    - UW: Receives funding through the student activity and sustainability fund.
    - WSU: Food Pantry fee \$5/semester to fund a full-time position and 4 student positions dedicated to the pantry and promoting food security initiatives starting 2021-2022

## Looking Ahead & Renewal

- Renewal/Re-Registration: The process of renewal is to re-register the organization from year to year. Renewal is defined as the yearly re-registration and update for all RSOs. Renewal includes updating an RSO's roster, officer positions, constitution amendments, and any other changes that were made the previous year.
- Requirements to Maintain Active RSO Status: \*Complete the Renewal process each Spring as announced by SLICE. \* (RSO Handbook 2023)
